7-010 NURTURING BY ELDERS:

"children watch us...everything we do teaches children".

The Government of Carcross/Tagish First Nation laws and policies are based on the cultural values of the Tlingit and Tagish people. Our traditional beliefs, practices and laws are set out in "Book One: Government of Carcross/Tagish First Nation Traditional Beliefs and Practices". Book One and our Constitution are primary resources to interpret the intent and meaning of any part of this Act.

"Each generation has its challenges ...yeah... in my dad and mom's time it was very hard...they lost a whole family, four kids in one year gone to the sickness in Skagway ...they had to start all over again ...they didn't complain just got on with it ..did what they had to do yeah ...we did the same ...now the young to day have different challengesif they respect each other ...you know love each other then they can make it ..do good ...even better than we did."

Book Two focuses on our Family Law. It builds on and refers frequently to Book One containing the fundamental facts, beliefs, values, practices and principles that constitute our Kusteeyi (culture), our kusti (way of life), and our vision for our future.

"Reaching for help is an expected thing not a shameful thing. It is the way we give each other the honour of helping. It is the way we serve each other – the way we live the values of family, the way we stay a kwaan (community). Nowadays seems like people think asking for help is like admitting failure – you know, being asked to help is an honour. It is saying to another you are important."

"We're not here to serve ourselves – Dikee Aankaawu (creator) made everything for a purpose and that purpose is to serve others, - like the moose serves us, the wolves, bears, even the plants in both its life and death – all things, all of nature same thing – it is about serving others – we do so in life and in death."

Based on these principles and responsibilities as passed down throughout our traditional oral history, translated and written into Book Two (2) section 5.0 of our Family Act, we look to our Elders to act as our leaders in the community. Elders are examples to all children, for better or for worse. They are teachers, they are caretakers and must lead by example, for the well-being of our Kwaan (community). They play a vital role in teaching the customs and traditions to everyone in the community. The lessons that they pass down are key to developing a healthy and sustainable Kwaan (community).

"This lake here, this mountain there, that river round that point, and all the wild things that live here; it is all one; and without all these parts we could not live here. Nothing could live here. We forget that eh? Not ours for just taking; but ours to look after; to look after real good eh. We need to respect all these things. It is same as looking after our children. Same thing eh, respect all things, or we have nothing, nothing to leave for next generations. We got big responsibility to respect what we have here".

Elders are valued for their wealth of knowledge, their experiences and should remain a vital resource for the community.

"It is the hardest thing I have ever done and will be the hardest thing we will all be called on to be...honesty is not an easy path but it is the only true path... and the start is no easier than any part of the journey".

As such, the Carcross/Tagish First Nation Elders' Policy was developed to provide the Governing body with certainty and consistency when managing with the health, well-being and services available to all Carcross/Tagish First Nation Elders.

"It's a life time thing you know ...these people are my people ..known them since I was born ...will know them when I die ...they've known me since I was born... Dikée Aankáawu (creator) gave each of us the others we live along side ... Dikée Aankáawu (creator) expects us to look after each other ...to look after Dikée Aankáawu's (creator's) giftgotta remember that eh seems like we forget that most times...we need to be like one big family ..like a big family we got troubles... lots of troubles all the time ...it's how we get through these troubles that makes us a family....each one of us is important.. lose one and family suffers ..don't matter who it is eh.. lose one we are not the same what we really got that is most important is each other lose that feeling of belonging and we are really done for..."

7-020 ORGANIZATION OF THE CARCROSS/TAGISH FIRST NATION ELDERS' POLICY MANUAL

The sections of this manual integrate policies and procedures.

Policies are authorized by the Chief/Deputy (Khà Shâde Héni) and the Executive Council. They direct the overall GC/TFN administrative affairs.

Procedures are developed by the administration to set out, in more detail, how certain policies will be carried out for the purpose of consistency and fairness.

Policies must always comply with the GC/TFN Constitution, treaties and laws, or, in some cases, with the legislation and labour codes of other levels of government.

Procedures must always comply with respective policies.

7-040 BENEFICIARY ELIGIBILITY

SCOPE Carcross/Tagish First Nation Elder Citizens.

PURPOSE To establish Carcross/Tagish First Nation Elders eligibility for Elders' benefits.

POLICY To be eligible for Elders' benefits with the Carcross/Tagish First Nation, beneficiaries must be enrolled as a citizen with the Carcross/Tagish First Nation as defined in section 2.0 the C/TFN Citizenship Code, and only be enrolled with the Carcross/Tagish First Nation.

Beneficiaries are entitled to Elders' benefits the month of their birth date and benefits will not be retroactive.

Elders eligibility will be verified to ensure that they comply with policies before receiving Elders' benefits with the Citizenship Office.

PROCEDURES Beneficiaries must provide the Carcross/Tagish First Nation Citizenship Office with necessary information and documentation in order to establish eligibility for Elders' benefits.

The Carcross/Tagish First Nation Elders' Policy and Procedures Manual is available online, on the C/TFN website. Additionally, copies can be obtained for pick-up from the main C/TFN governance office.

The Citizenship Office will provide Department Directors with the updated Elders eligibility list.

The Citizenship Office will track, update and record Elders eligibility to receive benefits on a timely basis.

7-050 THE ELDERS' COUNCIL

SCOPE Carcross/Tagish First Nation Elders who are also Clan Appointed Elders' Council Representatives.

PURPOSE To provide the Elders' Council with consistency, certainty and fairness when establishing criteria for its priorities and determining conduct and expectations of its members and Council Representatives.

POLICY As mandated by The Constitution of the Carcross/Tagish First Nation, The Elders' Council shall exist as a branch of the Carcross/Tagish First Nation Government. As such, the C/TFN Elders' Council may provide advice and guidance to the General Council, the Executive Council and to the Carcross/Tagish First Nation Government.

The Elders' Council shall establish the criteria for the determination of its membership based on the historic tradition and customs of the Carcross/Tagish First Nation, so long as its membership remains a Clan based system.

The Carcross/Tagish First Nation Elders' Council shall act as the Citizenship Committee.

PROCEDURE All meetings held by the Elders' Council shall be governed by the "Code of Conduct and Ethics" as mandated in the Constitution of the Carcross/Tagish First Nation, [section 7.4].

The Elders' Council shall appoint one Elder to represent the Wolf Clans, and one Elder to represent the Crow Clans to sit on the Executive Council in accordance with its procedures. These appointed Wolf and Crow representatives shall be responsible for keeping the Elders' Council informed of the business of the Carcross/Tagish First Nation Government.

It is the responsibility of each Clan Appointed Representative to conduct themselves in an appropriate manner as mandated in [section 7.5] of the Constitution of the Carcross/Tagish First Nation. Failure to act in accordance with [section 7.5] of the Constitution may result in immediate removal from the position by the remaining members of the Elders' Council .

The Elders' Council leadership will consist of one (1) Clan Appointed Elder Representative to speak and act on behalf of their Clan. Each of the six (6) Clans of the Carcross/Tagish First Nation will choose and appoint their Elder Representative and one (1) alternate, at an official Clan meeting and provide a written decision to the C/TFN Governance Office, naming the appointed Elder to represent their Clan on the Elders' Council.

Each Elders' Council member and alternate will be required to serve a term of up to four years dependent upon their date of appointment. After the four year term each clan may re-appoint their previous member and/or alternate or select a new representative and/or alternate. Each clan, may at any time, remove or change any of their respective appointee and/or alternate, and must notify Elders' Council and the Governance Administration in writing about any such removals or changes.

The Appointed Elders' Council Reps shall identify a Chairperson to oversee the activities of the Elders' Council. Duties of the Elders' Council Chairperson's responsibilities shall be defined in [Section 7-060] Statement of the Elder's Council Chairperson's Responsibility.

Meetings shall be held approximately once every two months, and shall be open to all citizens as observers. Disruptive behaviour will not be tolerated and anyone may be asked to leave the meeting at any time by the Chairperson.

Anyone under the influence of drugs or alcohol must not attend meetings. Anyone under the influence of drugs or alcohol will be asked to leave immediately.

Citizens wishing to make a presentation to the Elders' Council may submit their request in writing to the Chairperson and or Governance Manager, no later than two working days before the next scheduled meeting to be placed onto the agenda. This notice may be waived by consensus of the Elders' Council only if the Agenda allows.

The Elders' Council meetings will be documented by video.

Special sensitive situations may require the session to be in-camera requiring Non-Elder spectators remove themselves from the meeting as required and determined by the Chairperson.

Quorum shall consist of at least five (5) out of six (6) appointed representatives or alternates. All business of the Council shall be conducted by consensus. Consensus of a motion may only be passed when four (4) out of the six (6) appointed

representatives are in favour and pass the motion of resolution.

Appointed Elders' Council members have the following roles and responsibilities:

- ⌚ attend all Elders' Council meetings where possible,
- ⌚ conduct themselves in accordance with the Virtues and Values at all times during meetings;
- ⌚ act as a liaison to their clan members;
- ⌚ sign and adhere to code of ethics.

The Governance Department will provide assistance to the Elders' Council in a number of areas including:

- ⌚ Administrative support, such as scheduling and coordinating meetings and providing necessary information such as:
 - ⌚ Agendas;
 - ⌚ Supporting Documents;
- ⌚ Technical support;
- ⌚ Provide secretarial support during Elders' Council meetings, including documentation of discussions recommendations and meeting summaries;
- ⌚ Video recording sessions, posting, digital copies(available upon request) and archiving;

The Governance departmental budget will allocate funds to cover all applicable expenses related to Elders' Council operations. Expense categories include honorarium, travel, supplies, technical support and other costs the Elders' Council needs to ensure effective discussion and recommendations are carried out.

Expenses will be dispersed in accordance with the policy and procedures as described in [Section 2-0320] Honorarium and [Section 2-0335] Travel Claims and Regulations, of the Financial Policy.

7-060 STATEMENT OF THE ELDER'S COUNCIL CHAIRPERSON'S RESPONSIBILITY

The Appointed Elders' Council Representatives shall identify an Elder's Council Chairperson to oversee the activities of the Elders' Council.

The Elders' Chairperson achieves objectives by operating as a liaison between the Elders' Council and the C/TFN Senior Government Official by ensuring that clear lines of communication remain open between these governing bodies.

The Chairperson understands that Elders and employee's respond to fair and just treatment, and that GC/TFN policies within this manual will apply equally to all Elders.

Chairpersons take a sincere interest in the welfare and personal lives of Elders, respect their privacy and maintain a high degree of integrity and confidentiality, but discourage the interference of Elders personal matters with the day to day operations of GC/TFN.

Chairpersons act in a professional manner to set a role model for all Elders and review the performance and conduct of Elders at all times during official Elders' Council meetings.

The Chairperson shall be responsible for;

1. calling the meeting of the Elders' Council,
2. coordinating meetings and review agenda items;
3. chairing the meetings of the Elders' Council;
4. any other duties or direction set out in these rules of procedures or as directed by the Elders' Council.

7-110 TRADITIONAL PURSUITS

SCOPE Carcross/Tagish First Nation Elders' Beneficiaries residing in the geographic area of the Yukon Territory.

PURPOSE Ensure healthy perspective of one's culture through the customary practice and teachings of special skills and knowledge of traditional activities.

Elders will be eligible for the following items:

- Beads, not exceeding \$50.00 every two years,
- 1, 5'x4' skin or Stroud every two years,
- 1, 50 yard fish net or 1, 10'x12' wall tent every five years,

Elders requesting a large skin or Stroud or tent or longer fish net will be required to pay the difference in purchase price.

Heritage and Natural Resources Department may provide the following:

- 1-2 Salmon during the fall season(when budget allows),
- Meat harvested from road kill or through donations,
- A list of hunters that Elders can choose from to hunt for them, pursuant to the C/TFN Wildlife Act being established,

POLICY Traditional Pursuits annual budget will not exceed \$10,000.00, or as budget allows.

There will be no advance issuing of Traditional Pursuits products.

Annually in April of each year, Carcross/Tagish First Nation will place one (1) order for products.

All applications or written requests received during the fiscal year will be processed in April of the following fiscal year.

Late applications received after the yearly April intake will not be eligible for consideration until the following intake.

PROCEDURES

An application for Traditional Pursuits must be filled out or all requests must be submitted in writing to the Heritage Department.

Applicants' eligibility will be verified to ensure that they comply with policies the Citizenship Office.

The Heritage Manager will review all application or written request immediately upon receipt

The Heritage Department will document the decision on the application or written request and notify the applicant.

7-120 ELDERS' GIFT

SCOPE Carcross/Tagish First Nation Elders' Beneficiaries.

PURPOSE Promote health and well-being during summer and winter solstice celebration.

POLICY Annually in June and December of each year, Carcross/Tagish First Nation will issue Elder's \$1200 gift payments.

PROCEDURE Elders eligibility will be tracked by the Citizenship Office.

Elders will receive gifts of \$1200 twice a year. These will be processed June 21st for Solstice Celebrations and before the Christmas holiday period.

7-130 EMERGENCY HEALTH & MEDICAL ASSISTANCE

SCOPE Carcross/Tagish First Nation Elders' Beneficiaries.

PURPOSE To provide alternative financial assistance to Elders for travel associated to their health and spiritual wellness.

POLICY Emergency Health & Medical Assistance annual budget will be determined and handled through the C/TFN Health & Wellness Department.

Financial assistance will be provided ONLY when other Territorial and Federal Government assistance, or other third party medical assistance is NOT available.

Requests for assistance can be made to the Health & Wellness Director through the Youth & Elder Coordinator. Approval will be determined by the Health & Wellness Director and for exceptional circumstances, consultation may include Management Board.

Travel assistance will be provided for one designated family member to escort the Elder.

A Medical Emergency will be determined by the Elders' family physician and include:

- Life threatening evacuation,
- Life threatening condition,
- Critical medical,

Medical emergency travel assistance outside the Yukon may be approved up to a maximum of \$2500.00, and may consist of:

- One round trip airfare,
- Daily expenses,

Medical emergency travel sponsorship within the Yukon may be approved up to a maximum of \$1000.00. Medical emergency travel sponsorship must be in accordance with C/TFN Travel Guidelines and may consist of:

- Transport expenses,
- Daily expenses.

PROCEDURES

Requests for Emergency Health & Medical Assistance can be made to the Youth & Elder Coordinator. The Youth & Elder Coordinator will work with the Elder to ensure any and all paperwork needed is in order and bring the request forward to the Health & Wellness Director.

The Health & Wellness Director will review all requests upon receipt.

The Health & Wellness Director will document the decision on the request and notify the Elder and their escort as soon as possible.

7-215 HOME SUPPORT

SCOPE Carcross/Tagish First Nation Elders residing in traditional C/TFN territories of Tagish, Carcross and Squanga.

PURPOSE To provide Elders with home support so that they can remain independent within their own home and community for as long as practical, while enabling the Elder a good quality of life.

Home support provides routine basic needs once per week consisting of;

- light housekeeping service,
- meals on wheels,(when required)
- health and safety home hazards,
- medical and health related transportation,(based on need)
- shopping for necessities(based on need)

POLICY Home Support annual budget will be determined and handled through the C/TFN Health and Wellness Department.

Elders with medical conditions that can be confirmed by a Health Care Professional and have insufficient family support may be eligible for home support.

The Health & Wellness Department will conduct a home support visit to evaluate and identify the Elders social, emotional, physical needs and nature of home support to be provided.

Home support visits determine when an Elders social, emotional and physical needs may be beyond the scope of this policy. The Health & Wellness Director will identify and assist the Elder or family members with other Territorial, Federal or third party assistance programs when necessary.

Exceptional circumstances may apply and will require approval from the Health and Wellness Director, Senior Government Official and/or Management Board.

PROCEDURES Elders may make their request known to the Youth & Elder Co-ordinator. The Youth & Elder Coordinator will bring their request to the Health & Wellness Director for review.

The Health & Wellness Director will review all requests immediately upon receipt and notify the applicant after a decision has been made.

7-216 HEATING SUPPLEMENT

SCOPE: Carcross/Tagish First Nation Elders whose primary residence is located on Carcross/Tagish First Nation Settlement Land.

PURPOSE Ensure Elders can live a healthy and independent lifestyle during winter months without hardship.

The heating supplement will be provided to the Elders' primary residence home.

Homes without a wood stove are not eligible for wood delivery.

PROCEDURES The total heating supplement consisting of either \$600.00 or three(3) cords of wood(split and piled-if requested) will be provided to each home where one or more Elders are the primary resident.

Disbursements will be distributed on the 15th, of October, December and February of each month to each eligible Elder's residence.

The Youth & Elder Coordinator will work with each Elder's household to determine how they would like the supplement to be dispursed.

7-220 COMMUNITY SERVICES

SCOPE Carcross/Tagish First Nation Elders whose primary residence is located on Carcross/Tagish First Nation Settlement Land.

PURPOSE Ensure Elders can live a safe, healthy and independent lifestyle within their home and community.

POLICY The annual budget for community services will be determined and handled through the Infrastructure and Finance Department..

Capital Projects provides the following basic community services to Elders consisting of but not limited to;

- Water Delivery (Twice a week)
- Septic Pump-outs (Twice a month)
- Snow Removals (As Required)
- Water Tank Cleaning (As Required)
- Smoke & Carbon Monoxide detectors, fire extinguishers,
- Furnace Servicing,
- Emergency renovations(To be determined)
- Chimney cleaning(Fall and Spring)

Community services will be provided when other Yukon or Federal Government services are not available
