



Housing Application

Eligibility

In order to be considered eligible for Rental Housing a person must:

- 1) Be a C/TFN citizen/beneficiary or a parent with C/TFN dependants;
- 2) Be nineteen years of age or older, or be considered a responsible adult;
- 3) Be in good financial standing with C/TFN, or willing and able to sign a repayment agreement

Application Process

- 1) Rental Housing Applications must include a cover letter
- 2) The application must include two rental references/or should indicate if there is no rental history
- 3) Indication of source of Income must be included when applying, and confirmation must be provided when requested by Housing Team
- 4) Applications can be mailed, emailed, hand delivered, or submitted online to the Main Administration Office at C/TFN or the Infrastructure building during office hours of 8:30 am to 4:30 pm Monday to Friday with the exception of holidays.
- 5) Once an application is received it will be reviewed for completion and submitted to the Housing Team for review and or acceptance
- 6) Once the application has been accepted, the applicants name will be added to the waitlist with their original date of application.
- 7) Once your application is accepted it is the applicants responsibility to update their information as it changes for example, housing needs, size of family, income, contact information etc.
- 8) If an opening for a home becomes available for you, you may be asked to provide additional information to C/TFN such as proof of your current income, and verification that you are in good standing with C/TFN
- 9) Once accepted you will be sent a letter indicating you are on the waitlist for housing with C/TFN
