## **Personal Wood Permit Conditions**

- 1. Non-adherence of the permit conditions may result in cancellation of the Personal Wood Permit.
- 2. The Permittee shall not deny other person access to the permit area.
- 3. Personal wood permits cannot be transferred or assigned to another person.
- 4. The Permittee must have the permit on his/her person during harvesting and transporting of firewood.
- 5. Firewood must only be harvested in the areas stated on the application.
- 6. This Personal Wood permit is valid for one year or until the permitted volume has been harvested, whichever comes first.
- 7. The Permittee shall ensure that there is no cutting within 100 feet of the high water mark of the water bodies.
- 8. The Permittee shall ensure that all trees are utilized to a top diameter of 3 inches.
- 9. The Permittee shall ensure all tops and limbs left on the forest floor are lopped and scattered to lay flat on the ground.
- 10. The Permittee shall keep all tree stumps 6 inches or lower as measured from the highest point of the surrounding ground.
- 11. The Permittee shall not harvest during times of extreme fire hazard. A fire bottle containing retardant must be on hand while harvesting during the fire season April 1 to September 30.
- 12. The Permittee must use existing trails only; cutting and clearing new access trails is not permitted.
- 13. The Permittee must not dispose of any garbage in the cutting area.
- 14. The Lands Management Board has the right to cancel or temporarily suspend this permit due to unfavourable terrain conditions or if any of the terms and conditions of the permit are violated.
- 15. No cutting within 700 feet of private property.
- 16. Only snowmobiles or ATV's are permitted off main access trails.
- 17. Only dead/dry timber can be harvested on this permit; no green timber can be harvested.
